The production company agrees to indemnify the owner of the property for any damage that it may cause and remains the sole and absolute liable for any claim, proceeding or lawsuit for personal injury or property damage that may occur or that may arise from the exercise of the activities of the applicant, its employees or others. The production company is forced to contract and submit a liability insurance in order to obtain the accreditation and must send us both the name of the insurance company and the corresponding policy number. This insurance policy is responsibility of the client and must cover all the liability risks that may arise by reason of this authorisation. All municipal ordinances in filming and photo sessions must be respected, taking into account also the special protection of historic buildings, parks and gardens. This permit may be revoked at any time, i.e., authorisation is granted at will and can be modified, or even cancelled, at any time on justified grounds without the permit holder being entitled to indemnification or compensation whatsoever.
